HR Updates

Parents' Benefit: We have had a number of queries about the legislative changes to Parents' Benefit, which are due in April. Parents' Benefit will increase from 2 weeks to 5 weeks for each parent. The period it can be taken in will be extended up to your child's second birthday, or within two years following adoption placement. You will be able to take 5 weeks together or take separate weeks of leave. As soon as we receive official confirmation of the details, I will communicate them to you.

Higher Education Payroll Shared Services Project (HEPSS): UL is one of four higher education bodies taking part in this Shared Service proof of concept model for Payroll and Expenses as part of the Public Sector Reform Plan. The other three are Trinity College Dublin, Waterford Institute of Technology and Marino Institute of Education.

Payroll will be processed by the Education Shared Business Services Centre (ESBS) instead of by each individual institution. You will not need to do anything and there will be **no** change to your pay dates. UL and ESBS are still working towards a start date for this process and I will let you know when it is agreed. Annual Leave: Please plan and book your annual leave over the summer months in good time. If you carried over days from 2020 into 2021, you need to use them by the end of June this year.
