New Academic Year Guide for Staff Updates

There was considerable feedback from our academic and teaching staff about difficulties caused by the requirement to wear face-coverings while teaching. These were reported to the SMC and taking these concerns into account and the sectoral approach to the wearing of face-coverings in Ireland, our guidelines have been modified.

NEW 6.16 What safety guidelines should I follow before each lecture / class on campus?

- a) Ensure you are wearing a face covering when entering the lecture theatre /classroom,
- b) Confirm that the windows are open if windows are provided in the area,
- c) Advise students on the sanitisation products available for use,
- d) Conduct sanitation of the lectern area as required,
- e) Remain at 2m distance during the lecture.

AMENDED 6.17 Can I remove my face covering when I am teaching?

A lecturer may remove their face covering in a teaching and learning environment where all of the following apply:

- a) They are actively delivering a teaching session,
- b) They are >2m from students and can maintain this distance throughout,
- c) They are comfortable to do so, and
- d) Delivering the session without a face covering would mean an enhanced pedagogical experience.

If you are in a teaching or lab space that does not allow for the 2m distance from students, you should continue to wear a face covering.

Any student who may have an impairment that could hinder their participation in face-to-face classes where a lecturer needs to wear a face covering because these criteria cannot be met, should notify their course director and a solution will be found. This may involve the provision of existing lecture material, the replacement of the lecturer's face-covering with a face-shield, the use of amplification or another solution. Face-shields are also used by staff where necessary on specific courses e.g., Speech and Language Therapy.

AMENDED 6.15 How do I determine when it is appropriate to provide additional learning resources to vulnerable students?

A student must self-declare in writing (email) to their Module Co-ordinator that they are at a **Very high risk (extremely vulnerable)** from COVID-19 in line with Public Health guidelines detailed here.

Worker Representatives

With many more staff on campus, there has been a requirement for more <u>Worker Representatives</u> (WR) on site. Many departments and divisions have met this need by nominating increased numbers of staff for training in this role. There may also be locations where areas in close proximity that have prepared separate Business Response Plans can collaborate in scheduling their WR staff, to ensure that at least one WR is on site at all times.
