#### CONTEXT

Name of Creator(s): Healy, Michael.

Administrative/ Biographical History: Michael Healy was a native of Limerick and joined the Irish Volunteers in 1917 when they were being reorganised following the 1916 rising. He was promoted to Captain in the Volunteers and was heavily involved in IRA activities during the War of Independence. Healy took the Anti-Treaty side during the Civil War. He remained in the IRA following the end of the Civil War and was involved in its reorganisation until at least 1924. He appears to have been involved in helping to expedite the application process for military pensions for members of his company and battalion in c. 1940. He is recorded in 1956 in Dáil records as having been in receipt of a government pension having served in the War of Independence. Little is known about his life outside of the IRA except that he lived and worked as a shoe repairer at No. 38 Nicholas Street, Limerick City.

**Archival History:** The archive was discovered in the attic of a house in Meelick, County Clare. Michael Healy's connection with the house or its occupants is not known.

**Immediate Source of Acquisition:** Purchased at auction in Limerick in four separate lots on 4 July 2012.

#### CONTENT AND STRUCTURE

**Scope and Content:** The collection comprises papers relating to C Company 2nd Limerick City Battalion Mid Limerick Brigade 1917-1924 and includes narrative accounts of the Brigade activities during the War of Independence and information on the reorganisation of the Limerick Brigades during and following the Civil War. The collection is unusual as the anti-Treaty IRA was considered to be an illegal organisation and their records as a consequence were usually kept secret.

Appraisal, Destruction and Scheduling Information: All records have been retained.

Accruals: No accruals are expected.

**System of Arrangement:** The material has been divided into four series reflecting the form of the records and thereunder arranged chronologically by date.

1/1 November 1921 Softback ledger containing a list of stores at hand of G Company 2nd Limerick City Battalion Mid Limerick Brigade. Also a list of the subscription contributions of the G Company's officers and men for the week ending 6 November 1921, listing the name, address and occasionally occupation of each contributor; and a list of G Company's expenses for the same week. The rest of the ledger is blank. *Fragile*.

1/2 27 November 1921 Receipt for three weekly collections from the Quarter Master of C Company.

2/1 14 September 1922 General order from Sean Fitzpatrick, Divisional Adjutant, IRA Headquarters, Mid Limerick Brigade, to the B Company relating to the selection of men for Active Service Units.

From Brigade Adjutant, Head Quarters, Mid Limerick Brigade, to Brigade Intelligence Officer relating to the need to locate and identify all IRA Volunteers who were killed during the War of Independence and Civil War and buried outside their home areas.

2/3 10 October 1922 From Mid Limerick Brigade Head Quarters to Officers Commanding relating to steps needed to reorganise Mid Limerick Brigade.

2/6	6 January 1923 From T. M., Adjutant, Mid Limerick Brigade, to Officer Commanding 2nd Southern Division relating to on-going attempts to contact Brigade Officer Commanding L. Forde, and the low morale among the Volunteers still fighting. 1 p.
2/7	13 September 1924 From Adjutant General, General Head Quarters, Dublin, to Officers Commanding Divisions and Independent Brigades appealing for funds from graduates to aid students whose studies have been interrupted by the War of Independence and the Civil War. 1 p.
2/8	19 September 1924 From P. H., Battalion Officer Commanding, Head Quarters 2nd Battalion, Mid Limerick Brigade, to Brigade Adjutant, acknowledging receipt of an unspecified dispatch. 1 p.
2/9	14 October 1924 From Adjutant, Head Quarters, Limerick County to Adjutant, Mid Limerick Brigade, enclosing forms (now not present) to collect information to ensure that men disabled in military service will receive medical and financial aid. 1 p.

#### 3 REPORTS AND LISTS (1940)

#### **3/1** 26 June 1940

Handwritten account of the formation, personnel and activities of C Company 2nd Limerick City Battalion, Mid Limerick Brigade, between April 1917 and June 1921, prepared for the Military Service Pensions Board to aid the cause of claimants applying for service certificates. Lacking pp. 16-17 and with inconsistent pagination and narration, suggesting that the document was written in several parts or is a compilation of two or more reports. Also a related handwritten list of 51 operational and other activities and the names of participants in each activity, lacking pp. 5-8 and 43-49 and incorporating pp. 16-17 of P48/3/1 (2). Also a cover letter to the Service Pensions Board. *Fragile*.

Typed document providing an account of the formation, personnel and activities of C Company 2nd Limerick City Battalion, Mid Limerick Brigade between April 1917 and June 1921, based on but not identical to **P48/3/1(2)**. Also complete and incomplete copies of the same document, and slightly differing versions of the original text but with a broadly similar narrative.

Typed summary detailing the formation, activities and operations of C Company 2nd Limerick City Battalion, and the formation of the Limerick City Active Service Unit, including a list of the names and addresses of its members. Typed list of operations and activities in which officers and volunteers of C Company 2nd Limerick City Battalion, Mid Limerick Brigade and the Limerick City Active Service Unit were engaged in during the War of Independence, and a list of names of the men involved in each operation. With handwritten additions and amendments. The document is similar but not identical to P48/3/1 (3).
