What we have been doing ...

The First Limerick Conference titled »Irish-German Connections – Culture / Business / Politics« took place on 4-6 September 1997 at the University of Limerick.

It was organized by Drs Gisela Holfter and Joachim Fischer in coordination with the Heinrich Böll Stiftung, Berlin. The Conference, opened by the then German Ambassador to Ireland, His Excellency Horst Pakowski, attracted over 80 participants and proved to be a highly successful event. The organizers appreciated the sponsorship for the conference of the Heinrich Böll Stiftung, the Goethe-Institut, Dublin, the German Ireland Fund, the German Embassy in Dublin, the Plassey Campus Centre and the Irish Translators' Association. of Trinity College Dublin, officially launched the Centre for Irish-German Studies during the conference.

The Conference Proceedings, which have just been published under the title »Deutsch–Irische Verbindungen« contain papers in the areas of literature, history and translation. A selection of the contributions in the areas of politics, cultural relations and business will appear in the Centre's Yearbook (see below).

The Centre has instituted a series of Irish-German Business lectures to take place each spring semester. The series began in spring 1998. The speakers of the first series were Mr. *Philipp Hergett*, Hon. Consul of the Federal Republic of Germany in Galway; Dr *Dieter Tscherning*, Director of the German-Irish Chamber of Commerce, Dublin; and Mrs *Johanna Saar*, Managing Director, Irish Dresden.

Addressing cultural issues, the cigs welcomed in March 1998 Dr *Paul F. and Silvia Botheroyd* of Ruhr Universität Bochum who lectured on »The wondrous world of screen translation«, and *Donato Tangredi* M.A., Universität Tübingen who introduced UL students to the »Tübinger Modell einer integrativen Landeskunde«.

Mia Lerm-Hayes, of University College Dublin, visited the Centre in November 1998 to give a lecture on the influence of James Joyce on the work of Joseph Beuys, one of post-war Germany's most influential and controversial artists. Another distinguished guest lecturer to have visited the Centre in November was *Dr Ian King*, of South Bank University, London, who presented his assessment of »The German Elections: A Red/Green Future?«.

This summer, the Centre was instrumental in bringing the First German-Irish Masterclasses for Wind / Brass Instruments and Harp to the University of Limerick. They were organized jointly by the Goethe Institute, Dublin, GIC Promotions, Düsseldorf and the Centre for German–Irish Studies. Taught by highly acclaimed musicians, the Masterclasses attracted many students from both Ireland and Germany. A highlight was the final concert in the Jean Monnet Theatre on 18 July.

The Centre has established contacts with several Irish-German societies and the Austrian-Irish Society. In August 1998, the president of the Würzburg German-Irish Society, Mr Jürgen Gottschalk and his wife came to visit the Centre and contributed a number of publications to the Centre's book collection.

The Centre gratefully received Books worth £2,100 donated by a number of German publishing houses. They were added to the Centre's collection of German-Irish material.

The book collection, initially located in the Glucksman Centre, has now been relocated to the ground floor of the new Glucksman Library and Information Technology Building. The Centre also received a copy of the exhibition Heinrich Böll – Life and Work, from the Heinrich Böll Archive, Köln.

Ongoing Research

To encourage research is one of the Centre's priorities, both at postgraduate and postdoctoral level.

In collaboration with Dr Hermann Rasche, of NUI Galway, Dr Gisela Holfter is involved in research on German refugees in Ireland, 1939-1945;

Dr Joachim Lerchenmueller is working on the history of the ill-fated »Irish Brigade« in Germany,

the military unit set up within the German Army in late 1914 upon the suggestion of Sir Roger Casement;

Claire O'Reilly and Thomas Hippler, both postgraduate students, are carrying out research projects on the importance of inter-cultural studies for German-Irish business transactions, as part of a project supervised by Dr Gisela Holfter.
