Introduction

Twenty-five years is a considerable time in academia, also for a Research Centre. When we founded the Centre for Irish-German Studies at the University of Limerick in September 1997 it was an optimistic leap into the unknown, also on behalf of the University. We'd like to think that the initial leap of faith has been rewarded by the results documented in this commemorative brochure, which is an update of the booklet we compiled in 2017 for the first twenty years.

The aims we defined at the beginning in 1997 are still valid. The Centre encourages and supports research dealing with all aspects of Irish-German relation. The term 'German' in the Centre's name is to be understood in a linguistic rather than a geographical sense. Besides Germany, our work has therefore on numerous occasions focussed on Austria and Switzerland as well. In particular, the Centre aims

- 1. to encourage and facilitate interdisciplinary research into all aspects of contacts between Ireland and the German-speaking countries
- 2. to create a forum for discussion for interested parties, in the form of seminars, guest lectures and conferences
- 3. to co-ordinate and encourage the compilation of Irish material on Austria, Germany and Switzerland and German language material on Ireland as a resource base for researchers which is housed in the Glucksman Library (see below under Book Collection)
- 4. to increase knowledge about German-speaking countries, their societies and cultures as well as Irish-German relations in the region, and further promote mutual understanding.

In addition to numerous publications by individual members of the Centre (only the monographs are included in this brochure, otherwise it would have been substantially longer), the Centre issues a book series entitled *Irish-German Studies* (Wissenschaftlicher Verlag Trier) in which fourteen volumes have already appeared and two further volumes are in preparation. Several research projects are currently running under the auspices of the Centre, among them one on German Studies in Ireland. Completed projects include "German traces in Ireland" in cooperation with the Goethe-Institut Dublin, Ralf Sotscheck and Fintan O'Toole to which research links and references were added this year thanks to work done at the Centre, see https://www.goethe.de/ins/ie/en/kul/sup/dsi.html. Among the PhD students past and present several have been co-supervised with colleagues in Germany and Sweden; some are now teaching at universities and educational institutions in Ireland, Germany or Norway. An acknowledgement of the role the Centre has played in shaping the discourse on Irish-German relations was the recent visit to the University of Limerick by the President of the Federal Republic of Germany, Frank-Walter Steinmeier, and the President of Ireland, Michael D. Higgins, in October 2021.

At regular intervals, the Centre organises international conferences in Irish-German Studies, usually in co-operation with external organisations, such as the DAAD, the German, Austrian and Swiss Embassies, the Berlin-Brandenburg Akademie der Wissenschaften, the Goethe-Institut, the Heinrich Böll Foundation, the Konrad Adenauer Foundation (KAS), local history societies, the semi-state Electricity Supply Board and other universities in Ireland and abroad. While based in the School of Modern Languages, the

conferences have always aimed to facilitate interdisciplinary dialogue and this objective has been enthusiastically embraced by the speakers at the conferences, many of them leaders in their respective academic fields, as well as politicians (incl. Ministers, T.D.s, Members of the Bundestag (MdBs) and a former Taoiseach) as well as business leaders. Art exhibitions and music as well as involvement with and invitations to local community organisations have also been frequent elements of our activities. The conferences have been very successful in attracting audiences far beyond the academic sphere and have, in a number of cases, received considerable prominence in the Irish and German media. Our Irish-German book collection has grown tremendously in the last three years and now holds several thousand volumes. A considerable part of it is the Gottschalk Collection, donated in 2019 by the late Jürgen Gottschalk who spent decades collecting the largest private collection of German material on Ireland. We were delighted that President Steinmeier and President Higgins came to Limerick were both able to admire selected items of our Irish-German book collection in October 2021.

Our work over the last twenty-five years would not have been possible without the support of many colleagues, friends and institutions. Firstly, our colleagues in UL and Mary Immaculate College (MIC) who, hailing from a large variety of disciplines, have made the Centre the inter-disciplinary venture we had envisaged. Colleagues at other Irish universities and further afield have become active members and contributors to the Centre over the years and have lent it the international dimension we had hoped for. Our Advisory Board, consisting of David Donoghue (former Irish ambassador to Germany, Austria, Russia and the UN), Dublin; Dr Benedict Gubler, Swiss ambassador (ex officio), Dublin; Dr. Thomas Nader, Austrian ambassador (ex officio), Dublin; Cord Meier-Klodt, German ambassador, Dublin; Dr Nicholas O'Brien, Irish Ambassador (ex officio), Berlin; Seán Ó hUiginn (former Irish ambassador to Germany, US and Italy), Dublin; Prof. Emer O'Sullivan, Leuphana Universität Lüneburg; Dr Beate Schuler, Bad Homburg and Ulrike Gasser, Director Goethe Institut (ex officio), Dublin, has been a wonderful sounding board and fountain of wise counsel. Without the active and especially financial support of many bodies and institutions which saw value in what we do many of our projects would just have remained pipe-dreams. Only a few can be mentioned here, who have supported us on numerous occasions: the School of Modern Languages & Applied Linguistics and its predecessors; the Faculty of Arts, Humanities and Social Studies in UL; the Irish Research Council; the German, Austrian and Swiss Embassies in Dublin and the Irish Embassy in Berlin; the DAAD, the Goethe-Institut, the Heinrich Böll Foundation, the KAS, the German-Irish Chamber of Industry and Commerce, the German-Irish Lawyers and Business Association (GILBA), the DFA and and Auswärtiges Amt, Berlin. 



September 2022-December 2022

Féile Dánnerstag

Thanks to funding by Foras na Gaeilge we will be able to continue the 2021-2022 Dánnerstag project in a slightly different format as Féile Dánnerstag/ Dánnerstag Festival in the autumn of 2022. This time, we will be translating the other way around, from Irish to German, with a four-part Irish-German Poetry Festival: Gabriel Rosenstock (on 22 September, with Hans-Christian Oeser), Alan Titley, Julie Goo and Micheál Ó hAodha will take part in September, October, November and December 2022. Project leaders are Sorcha de Brún and Gisela Holfter, UL. The project is organised in cooperation with Aonad na Gaeilge, the Centre for Popular Music and Popular Culture and the Irish Chamber Orchestra.

January 2022 – December 2024

Promoting German Studies in Ireland - Exploring the past, enhancing the current position, and working towards 250 years of German Studies in Ireland, 2022-2024. Supported by the DAAD

The Centre was awarded project funding for Round V – 2022 to 2024 under the 'Promoting German Studies in the United Kingdom and Ireland' (PGS) scheme by the DAAD and will be working together with the German Studies Association of Ireland (GSAI) and the Business in Ireland Working Group (BuGI). Project manager is Prof. Gisela Holfter who is joined by Dr Marieke Krajenbrink (UL, GSAI co-chair 2019-21), Joseph Twist (UCD, GSAI co-chair 2020-22), Dr Linda Shortt (Maynooth, GSAI co-chair 2021-23), Dr Michaela Schrage-Früh (NUIG and deputy chair BuGI), Natascha Guggi (UL, Research Assistant). The project aims to promote German in Ireland and is articulated in three strands. Strand 1 'Exploring and learning from the past' is a book project with contributors from all Irish universities and several Institutes of Technology, resulting in a volume provisionally entitled 'Contributions to a History of German Studies in Ireland / Beiträge zur Geschichte der irischen Germanistik' (to be published in 2023). Strand 2 'Enhancing German Studies in Ireland today' will include a needs analysis of German at third level institutions today, link up of online resources, feature seminars and workshops and provide more support for incoming colleagues and postgraduate students. Strand 3 will be a conference in 2024, entitled 'Working towards 250 years of German Studies in Ireland'.

September 2021- May 2022

Dánnerstag — "Dánnerstag" is a new and innovative poetry project by the Centre for Irish-German Studies and introduces German language poetry and its Irish language translations to a local, national, and international audience. 'dán' in Dánnerstag means poem in Irish, and 'Donnerstag' means Thursday in German. Supported by the German, Austrian and Swiss Embassies and the DAAD. Chamber Director Ralf Lissek addressed the audience before the winners were announced: the 1st prize went to four UL 4th Year Students in International Business with German, Rhona Butler, Ciara Donnely, Amanda Gavin & Ciara Quigley. The 2nd prize was claimed by a team from UCC (Colin Moriarty, Niamh McDonagh, Sara Urbanska), the 3rd prize by NUI Galway (Katie Feerick, Ciara Long, Leoni Leonard, Victoria Osikoya). Special thanks to German-Irish Chamber of Industry and Commerce who have generously supported the competition.

The video competition is set to become an annual event in late February of every year.

2021-2022

Pilot-Project: Unternehmen Deutsch 2021/2022

The pilot-project entered its second phase in August 2021. Following a successful start at school level, it now runs at third level for the first time. The project promotes cooperation between Irish universities and German businesses. The project provides students with an opportunity of hands-on experience with foreign businesses and allows them to explore another language in a work environment as part of an innovative business-specific language course. The Business German in Ireland Working Group (BuGI) has worked together closely with the Goethe-Institut in Dublin in creating the educational material (with some input of the CIGS), under the lead of Dr Michaela Schrage-Früh (NUI Galway) in co-ordination with Prof. Gisela Holfter (BuGI chair UL), Orla Prendergast (UL), Sheree Borge (MY), Dr Deirdre Byrnes (NUI Galway), Karen Feery (TUD), Dr Claire O'Reilly (UCC) and Dr Andreas Boldt (Maynooth). Unternehmen Deutsch will be available to all third level institutions from 2022/23 onwards.

October 2019

Operation Shamrock. Research Project presented within a roundtable discussion and exhibition, which took place on 10 October 2019 in the Appellate Court in UL. Dr G. Holfter introduced the chair of the discussion board Dr Jérôme aan de Wiel (UCC), Monica Brandis (Berlin) the project manager of the exhibition and two of the former children who participated in Operation Shamrock, Klaus Armstrong-Braun and Friedhelm Krüll.

Operation Shamrock was part of a larger project set up by the Red Cross for children from Europe during and after the Second World War, who were provided with refuge in other countries. O.S. gave 500 German children from disadvantaged backgrounds a better chance in life in Ireland, which came on the Island after WWII for a short term stay up to three years. Fifty German children stayed permanently in Ireland.

As project manager Brandis underlined, O.S. was Ireland's first attempt of hosting children from countries such as France and Germany and was, therefore, a learning process, needing improvement, especially in the areas of information supply for children and families and the supervision of children. Nevertheless, the project "saved many children's lives" and was a significant connection between Germany and Ireland as well as a ground example of mutual support of countries in Europe.

2014/2022

German Traces in Ireland

Project designed by Goethe Institut Ireland, launched in 2014 by the German Ambassador to Ireland at the Goethe-Institut, Dublin. This project, available online or to download as an app, serves as an international travel guide to discover the traces of historical figures and events in Ireland. There are twenty-six traces in total, all of which are connected to both Ireland and Germany.

Some of the German Traces in Ireland include: German singer Agnes Bernelle, Richard Castle (architect from Kassel), writers Heinrich Böll and Annette Kolb, sculptor Imogen Stuart, the Hydroelectric power station at Ardnacrusha, the Irish Palatines and also the Children of Operation Shamrock.



The Loneliness of Being German: Exhibition of German born artists Vera Klute and Thomas Bezing at Limerick City Gallery of Art in Retrospect

From July to September 2021 the Limerick City Gallery of Arts (LCGA) hosted a double exhibition by German-born artists Vera Klute (http://veraklute.net/cv.html) and Thomas Brezing (http://thomasbrezing.weebly.com/). The exhibition was launched on 8 July at the Limerick City Gallery of Art. As an introduction, there was an in-house conversation between artist Vera Klute and Prof. Gisela Holfter as well as a poetry reading by the Irish poet Enda Wyley in dialogue with Thomas Brezing.

The exhibition was accompanied by a publication of a fascinating essay by Cherry Smyth, providing an insight into the poetry and aesthetics of the two talented artists. Klute's abstract landscapes look back on her childhood, idealizing the rural landscapes while portraying German provincial life of her childhood surroundings in its Kleinbürgerlichkeit (petty bourgeoisness), which she escaped from Brezing's work addresses the question of "otherness" and the existential loneliness of living in a foreign country, suggesting that the feeling of solitude belongs, also, to the nature of the artist, which appears to be the outsider and the stranger to this world. On the other hand, Brezing's collection features abstract paintings alluding to the social issue of migrants and refugees, a subject that pertains to Ireland's past and shapes German present.



Book Collection

Over the past twenty-five years the Centre for Irish-German Studies has compiled a significant collection of Irish-German materials, consisting chiefly of books, brochures, pamphlets and digital sources in German about Ireland and Irish materials about the German-speaking countries. The Irish-German Book Collection is available in the Special Collections of the Glucksman Library at UL (ground floor) for all pre-1900 books and other valuable documents), the bulk of the collection though is open-access and is housed on the second floor of the library in a specially devoted space.

A particularly valuable part of our holding is the Gottschalk Collection came to the Special Collections and Archives Department at the Glucksman Library in 2019, a treasure-trove of printed material related to Ireland, its literature, art, culture, music, past and present. This collection was a donation to the Centre for Irish-German Studies in UL by Celtic scholar Jürgen Gottschalk, who founded the Würzburg Irish-German Society in 1986 and devoted much of his life to promoting Irish-German friendship and scholarship. While Jürgen Gottschalk sadly passed away in October 2019, his collection which was probably the largest existing private German book collections on Ireland, will serve many readers, students and scholars coming from a variety of academic disciplines and interests. The Gottschalk Collection was officially opened to the public by German Ambassador Deike Potzel on 14 November 2019 and is currently being catalogued in the Glucksman Library.

Another substantial collection was given to the Centre in 2022. These were books from the late Otto Glaser who had come to Ireland in the late 1930s from Austria as a teenager and is featured in *An Irish Sanctuary* (2017), a book on German-speaking refugees in Ireland in the 1930s and 1940s by Gisela Holfter and Horst Dickel. Glaser became an important figure in the Irish telecommunication industry and was a towering figure in the Austrian-Irish Society. His book collection consists mainly of German-speaking books on Austrian literature, culture and politics, legal texts as well as books on sailing. Special thanks to Charlotte and David Delamer and H.E. Dr Thomas Nader and our UCD colleagues.



Dr Siobhán O'Connor was conferred with a PhD at the January 2010 University of Limerick graduation ceremony. Her thesis on "Public Opinion on German-speaking Refugees in Ireland" was supervised by Dr Gisela Holfter. External Examiner was Prof. Hamish Ritchie, Internal Examiner was Dr Joachim Fischer. She was joined at her graduation by her husband Brock, her son Ciaran and daughter Aisling.

I was working with Asylum Seekers in a direct provision centre in Ireland in 2003. I was curious how Irish society evolved that led people seeking refuge to have to spend time in these centres. At the same time Dr Gisela Holfter was formulating the IRCHSS Exiles in Ireland Project. It transpired that my historical curiosity lent itself to her work because German-speaking exiles were the first large group of people seeking protection in Ireland after Ireland became an autonomous state. I joined the team as a doctoral student.
