#### MG2082 EXPORT IN THE CONTEXT OF GLOBAL SUPPLY CHAIN:

The aim of this module is to provide learners with an understanding of the key principles underlying export procedures and protocols within the EU and globally. It will provide learners with an understanding of the legislative basis and the mechanisms required for export compliance.

#### MG2052 ADVANCED PRACTICES IN CLASSIFICATION:

This module will provide learners with an understanding and practical ability to correctly classify, value and determine origin for materials being imported or exported by their organisations, the legislative basis and the mechanisms required for import and export compliance. Participants will learn to understand their role in compliance with global trade regulations and to apply practical export knowledge within their organisation

#### MG2062 APPLICATIONS OF SECURITY CONTROLS:

The aim and objectives of this module are to provide learners with an understanding of the main import and export security controls. Participants will understand their and their organizations obligations in complying with these controls and understand the frameworks and structures both within the EU and Internationally.

#### MG2072 PRINCIPLES 2:CUSTOMS CONTROLS:

The aim of this module is to provide learners with an understanding of customs controls and how they impact the organisation. It will provide learners with an understanding of the legislative basis and the mechanisms required for import and export compliance with customs in the EU

This module will provide learners with an understanding of the principles of importing into the EU and Ireland, the legislative basis and the mechanisms required for import compliance
