The programme will appeal to personnel already working in the leasing sector who seek to upskill and broaden their knowledge; technical aviation personnel requiring leasing business knowledge and skills; and those working in the finance/legal/insurance sectors seeking to move their careers into the leasing sector. Applicants may be interviewed.

The KBS Professional Diploma in Aviation Leasing and Finance is delivered through online study via the University of Limerick online learning platform and through on campus workshops. Programme credits are 30 with a 15 to 20 hour workload per semester week.
